This position is based within the HART Hub, a 66-bed, two-site initiative providing a full continuum of addiction and mental health services across Lanark, Leeds, and Grenville counties. This role is specifically located within our 8-bed residential addiction treatment program, which is co-located with 12 supportive housing spaces. The HART Hub is designed to break down traditional service silos, integrating withdrawal management, intensive treatment, supportive treatment, and long-term housing to provide client-centered, continuous care.

As a Rehabilitation Worker I within the HART Hub, you will contribute to a therapeutic, safe, and supportive environment. You'll be responsible for helping clients maintain a clean and comfortable living space, attending to their well-being and safety, and supporting their journey through structured programming and daily living routines. This is a front-line opportunity to make a meaningful difference in the lives of individuals recovering from substance use and mental health challenges.

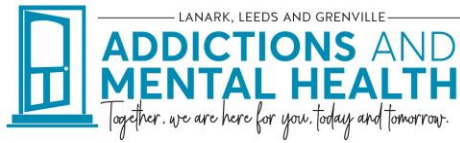
